

Rural VIP No. 20: Role of Rural Municipalities in Health Care

The twentieth survey for the members of the Rural Voice Information Panel (Rural VIP) was sent out on September 2, 2021 to 218 members.


Through this survey, we sought to understand to what extent rural municipalities are involved in health care, and the importance of health care for rural voters during the upcoming municipal elections.

This document provides a summary of the responses.


Key Learnings

- **Q1:** Over half of respondents have indicated that their local municipal government is **very** involved in health care in their communities.
- **Q2-3**: 58 per cent of respondents are aware of changes or initiatives that their municipal government have made in the past four years to improve their community's health. Examples of these initiatives include building medical centres in their communities, becoming involved in Attraction and Retention committees, and supporting a regional transportation project to improve access to health care services.
- **Q8:** Two-thirds of respondents will consider the health care platforms of the candidates running for municipal election when voting.

2. Are you aware of any changes or initiatives that your municipal government (village, town, or county council) has made in your community to improve health care in the past four years?






3. If you answered "Yes" to Question 2, can you please provide details of these changes or initiatives?




- "Reorganized our Health Attraction and Retention committee, established clear terms of reference, passed a policy for financial support."
- "Physical health promotion, Recreation Centre passes given for free to those with a prescription from physician to increase physical activity."
- "Obtained an MRI machine by fundraising."
- "Built a brand-new medical centre for our doctors"
- "Created and delivered a "Directory of Healthcare Services" available in our area, that included all Health Professionals."
- "Supporting a regional transportation project to enable users to get to services 111+ km away."




5. If you answered "Yes" to Question 4, can you please provide details of these advocacy activities?




- "Letters sent to the Health Minister."

- "Advocated for the province to provide mask restrictions for all the province and not leave it to individual municipalities."
- "Our local representatives write letters to our MLA. When our MLA meets with our council, they always bring up the lack of healthcare professionals at our hospital."

6. Over the last four years, how satisfied have you been with your municipal government's (village, town, or county council) involvement in health care in your community?








7. Is health care included on the platforms of the candidates running for municipal (village, town, or county council) election next month?




8. Will the health care platforms influence which candidates you vote for?
